RELATING TO AGRICULTURE.

AGR/EDB, FIN

Proposed HD1: Amends the Industrial Hemp Pilot Program by establishing a special fund administered by the Department of Agriculture. Restricts cultivation of industrial hemp under the pilot project to agricultural lands and requires counties to recognize it as an agricultural product, use, or activity. Amends license application and physical facility requirements.
