Status

RELATING TO THE HILO COMMUNITY ECONOMIC DISTRICT.      EDB/TOU, WAL,  
Establishes the Hilo community economic district located in East      FIN  
Hawaii and places it under the jurisdiction of the Hawaii community  
development authority. Establishes the Hilo community economic  
revolving fund. Requires all revenue, income, and receipts of HCDA  
for the district to be deposited in the Hilo community economic  
revolving fund, and a designated per cent to be transferred to the  
special land and development fund under the department of land and  
natural resources.

DECISION MAKING TO FOLLOW
