
SENATE CONCURRENT RESOLUTION

URGING THE DEPARTMENT OF EDUCATION, DEPARTMENT OF HEALTH,
DEPARTMENT OF HUMAN SERVICES, AND JUDICIARY TO PERMANENTLY
ESTABLISH AND PARTICIPATE IN THE HAWAII INTERAGENCY STATE
YOUTH NETWORK OF CARE TO BETTER SERVE YOUTH AND FAMILIES
WITH COMPLEX NEEDS IN THE STATE.

1 WHEREAS, the Department of Education, Department of Health,
2 Department of Human Services, and Judiciary are responsible for
3 serving the multiple needs of children, youth, and families; and
4

5 WHEREAS, many children, youth, and families, particularly
6 those with complex educational, behavioral, and social-emotional
7 needs, experience significant challenges and hardship navigating
8 the State's child-serving system; and
9

10 WHEREAS, children and youth with complex needs who do not
11 receive services face numerous negative consequences, including
12 lower educational achievement, increased likelihood of
13 involvement in the juvenile justice system, and fewer stable and
14 longer-term placements in the child welfare system than their
15 peers; and
16

17 WHEREAS, to better serve children, youth, and families, the
18 Department of Education, Department of Health, Department of
19 Human Services, and Judiciary have committed to the goals of the
20 Child and Adolescent Service System Program, including to:
21

- 22 (1) Promote the development of a wide array of services to
23 meet the needs of identified children;
24
- 25 (2) Integrate multiple services into a well-coordinated
26 system of care to make sure children are receiving the
27 most appropriate services; and

1 (3) Increase the ability of parents and professionals to
2 work together for the benefit of the children; and
3

4 WHEREAS, a seamless system of care has numerous positive
5 outcomes for children and youth, including the improvement of
6 school attendance and grades; increasing stability of living
7 situations; and decreasing behavioral health challenges, suicide
8 rates, substance abuse, and involvement in the juvenile justice
9 system; and
10

11 WHEREAS, the Department of Education, Department of Health,
12 Department of Human Services, and Judiciary formed the Hawaii
13 Interagency State Youth Network of Care (HISYNC) to increase
14 collaboration among state agencies and to develop a system of
15 care for children, youth, and families; and
16

17 WHEREAS, representatives of children, youth, and families
18 are included as valued HISYNC members and regularly attend
19 meetings to give recommendations and to ensure that the child-
20 serving system is responsive to the needs of children, youth,
21 and families; and
22

23 WHEREAS, the HISYNC members primarily work to improve
24 outcomes for Hawaii's children, youth, and families through:
25

- 26 (1) The continuous review and analysis of data to identify
27 areas for system and service improvement;
- 28 (2) The recommendation of policies to address barriers
29 within the child-serving system;
- 30 (3) Collaboration, coordination, and integration of state
31 programs, services, and resources;
- 32 (4) Planning on joint treatment and management of specific
33 youth; and
- 34 (5) Stakeholder problem-solving around multi-agency
35 challenges; and

1 WHEREAS, HISYNC has implemented and supported several
2 multi-agency initiatives to promote interagency collaboration,
3 including:

- 4
- 5 (1) A multi-agency memorandum of operation to formalize
6 partnership of the state agencies comprising the
7 interagency committee and to firmly establish the
8 committee's mission and vision;
9
- 10 (2) A multi-agency consent form for information sharing
11 that streamlines the process for parents to access
12 care, thus alleviating the often duplicative and
13 numerous forms that parents need to complete and sign;
14
- 15 (3) A jointly-funded independent facilitator position to
16 carry out the daily activities of HISYNC and the
17 Hawaii Interagency Local Youth Network of Care
18 (HILYNC) committees;
19
- 20 (4) An annual interagency report with data on youth
21 served, costs, and outcomes, which brings together the
22 story of youth in Hawaii with respect to how they are
23 being served and supported by child-serving agencies;

- 26 (5) Facilitating the development of local and regional
27 HILYNC groups, also known as HILYNC committees, to
28 promote interagency collaborative work on the local
29 level; now, therefore,
30

31 BE IT RESOLVED by the Senate of the Twenty-ninth
32 Legislature of the State of Hawaii, Regular Session of 2018, the
33 House of Representatives concurring, that the Department of
34 Education, Department of Health, Department of Human Services,
35 and Judiciary are urged to permanently establish HISYNC; and

37 BE IT FURTHER RESOLVED that the Department of Education,
38 Department of Health, Department of Human Services, and
39 Judiciary are urged to participate in HISYNC and HILYNC; and

41 BE IT FURTHER RESOLVED that HISYNC is urged to invite any
42 additional child-serving agencies to participate in HISYNC's



1 interagency forum and encourage these agencies to send local
2 representatives to each of the regional HILYNC committees; and
3

4 BE IT FURTHER RESOLVED that any additional child-serving
5 agencies not currently members of HISYNC are urged to
6 participate in HISYNC's interagency forum and send local
7 representatives to each of the regional HILYNC committees; and
8

9 BE IT FURTHER RESOLVED that HISYNC is urged to coordinate
10 the complex landscape of the child-serving system to better
11 serve children, youth, and families; and
12

13 BE IT FURTHER RESOLVED that certified copies of this
14 Concurrent Resolution be transmitted to the Governor,
15 Superintendent of Education, Director of Health, Director of
16 Human Services, and Administrative Director of the Courts.
