
SENATE CONCURRENT RESOLUTION

URGING THE UNIVERSITY OF HAWAII SYSTEM'S VICE PRESIDENT FOR
BUDGET AND FINANCE TO DEVELOP A PLAN TO REDEVELOP THE LOWER
CAMPUS OF THE UNIVERSITY OF HAWAII AT MANOA THROUGH A
PUBLIC PRIVATE PARTNERSHIP.

1 WHEREAS, the lower campus of the University of Hawaii at
2 Manoa has a vast amount of underutilized lands; and

3
4 WHEREAS, the University of Hawaii at Manoa Athletics
5 Department is in need of enhanced sports facilities for football
6 and other activities; and

7
8 WHEREAS, the University of Hawaii at Manoa Athletics
9 Department is constantly looking for new ideas to better utilize
10 its public spaces and generate more revenue; and

11
12 WHEREAS, currently, the Manoa campus is highly composed of
13 commuters, students who do not live on campus and need to
14 commute to and from campus on a daily basis; and

15
16 WHEREAS, the Manoa campus has potential to encompass a
17 "live, study, play" concept, similar to a university village or
18 to transitional housing for new graduates starting their
19 professional lives; and

20
21 WHEREAS, the redevelopment of the lower campus of the
22 University of Hawaii at Manoa should take a similar approach as
23 the development of the University of Hawaii West Oahu; and

24
25 WHEREAS, public private partnerships for redevelopment
26 offer opportunities to minimize the amount of capital the State
27 would otherwise need to provide; and

29 WHEREAS, public private partnerships also offer
30 opportunities to generate revenue and revitalize the Manoa



1 campus by establishing work force or student housing, areas for
2 commerce and businesses, restaurants, new athletic buildings,
3 fitness centers, and other community resources; now, therefore,
4

5 BE IT RESOLVED by the Senate of the Twenty-ninth
6 Legislature of the State of Hawaii, Regular Session of 2018, the
7 House of Representatives concurring, that the Vice President for
8 Budget and Finance of the University of Hawaii System is urged
9 to develop a plan to redevelop the lower campus of the
10 University of Hawaii at Manoa through a private public
11 partnership; and

13 BE IT FURTHER RESOLVED that the plan look at ways to
14 encompass a "live, study, play" concept, including but not
15 limited to opportunities for work force or student housing,
16 commerce, and other community resources; and

18 BE IT FURTHER RESOLVED that the Vice President for Budget
19 and Finance of the University of Hawaii System report to the
20 Legislature findings and recommendations on options for public
21 private partnership pilot projects no later than twenty days
22 prior to the convening of the Regular Session of 2019; and

24 BE IT FURTHER RESOLVED that certified copies of this
25 Concurrent Resolution be transmitted to the President of the
26 University of Hawaii System and Vice President for Budget and
27 Finance of the University of Hawaii System.
