SENATE CONCURRENT RESOLUTION

REQUESTING THE DEPARTMENT OF TRANSPORTATION TO CONDUCT A STUDY
OF PERSONAL VEHICLE RENTAL ORGANIZATIONS.

1 WHEREAS, public modes of transportation have transformed
2 over the years from traditional taxi services to individuals
3 using their personal vehicles for transportation services via a
4 transportation network company; and
5

6 WHEREAS, a new mode of transportation has recently
7 developed where private individuals are renting their personal
8 vehicles to other individuals as a commercial enterprise via a
9 third party web-based platform; and
10

11 WHEREAS, up to one hundred fifty personal vehicles are
12 available for rent, ranging from \$30 to \$350 per day, in the
13 State; and
14

15 WHEREAS, in many cases, these personal vehicles are being
16 rented to visitors and residents without any regulation,
17 resulting in a loss of revenue to the State; and

19 WHEREAS, renting personal vehicles on a fee basis via a
20 third party web-based platform is currently unregulated and as
21 such, there are no regulations in place to ensure that vehicles
22 are being rented to qualified individuals and have adequate
23 insurance coverage, and that vehicle safety standards are met;
24 now, therefore,

26 BE IT RESOLVED by the Senate of the Twenty-ninth
27 Legislature of the State of Hawaii, Regular Session of 2018, the
28 House of Representatives concurring, that the Department of
29 Transportation is requested to convene a working group to
30 evaluate the regulation of personal vehicle rentals and consider
31 practice standards for this industry to ensure the safety of the
32 public; and

1 BE IT FURTHER RESOLVED that the Director of Transportation
2 is requested to serve as the chair of the working group and to
3 invite the following individuals to serve as members of the
4 working group:

- 6 (1) The Insurance Commissioner or the Commissioner's
7 designee;

- 9 (2) The Executive Director of the Office of Consumer
10 Protection or the Director's designee;

- 12 (3) One representative from the Department of
13 Transportation;

- 15 (4) Two representatives from the motor vehicle rental
16 industry conducting business in the State; and

- 18 (5) Two representatives from the licensed automobile
19 insurance industry conducting business in the State;

22 BE IT FURTHER RESOLVED that the working group is requested
23 to submit a report of its findings and recommendations,
24 including any proposed legislation, to the Legislature no later
25 than twenty days prior to the convening of the Regular Session
26 of 2020; and


