Your Committee on Conference on the disagreeing vote of the House of Representatives to the amendments proposed by the Senate in H.B. No. 2134, H.D. 1, S.D. 1, entitled:

"A BILL FOR AN ACT RELATING TO VIOLATION OF PRIVACY,"

having met, and after full and free discussion, has agreed to recommend and does recommend to the respective Houses the final passage of this bill in an amended form.

The purpose of this measure is to amend the offense of violation of privacy in the first degree to:

- (1) Prohibit threats to disclose an image or video;
- (2) Specifically include disclosures that are acts of revenge or retribution; and
- (3) Require that any recording or image that is the subject of the offense be sealed and remain confidential.



Your Committee on Conference has amended this measure by:

- (1) Changing its effective date to July 1, 2018; and
- (2) Making technical, nonsubstantive amendments for clarity, consistency, and style.




