Your Committee on Intrastate Commerce, to which was referred  
H.B. No. 2149 entitled:

"A BILL FOR AN ACT RELATING TO DENTISTRY,"

begs leave to report as follows:

The purpose of this measure is to allow dentists flexibility  
in complying with continuing education requirements by requiring  
completion of six hours of ethics training every two years instead  
of three hours each year.

The Hawaii Dental Association and a concerned individual  
testified in support of this measure. The Board of Dental  
Examiners provided comments.

Your Committee has amended this measure by:

- (1) Changing its effective date to July 1, 3000, to  
facilitate further discussion; and
- (2) Making technical, nonsubstantive amendments for clarity,  
consistency, and style.

As affirmed by the record of votes of the members of your  
Committee on Intrastate Commerce that is attached to this report,  
your Committee is in accord with the intent and purpose of H.B.
