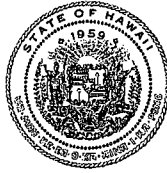

Dear President Kouchi, Speaker Saiki and Members of the Legislature:

Pursuant to Section 37-52.5, Hawaii Revised Statutes, this is to report to you that a trust account has been established for the Department of Budget and Finance. This new trust account is called the "Tobacco Arbitration Settlement Funds." The purpose of this new trust account is to facilitate the distribution of the tobacco lump sum settlement payment and annual tobacco settlement payment which are scheduled to be received by the State of Hawaii in April 2018. The establishment of this trust account serves as a temporary solution until the Legislature can act to resolve the disposition of the tobacco settlement moneys.
