
HOUSE RESOLUTION

REQUESTING THE HAWAII STATE JUDICIARY AND DEPARTMENT OF HUMAN SERVICES TO NOT USE BLINDNESS AS A BASIS FOR DENYING PARENTAL RIGHTS.

1 WHEREAS, blind individuals face certain preconceived biases
2 and attitudes in family and dependency law proceedings where
3 custody and visitation are at stake and in public and private
4 adoption, guardianship, and foster care proceedings; and
5

6 WHEREAS, nationally some children of blind parents are
7 unnecessarily being removed from their parents' care or
8 restricted from enjoying meaningful time with their parents as a
9 result of these preconceived biases and attitudes; and
10

11 WHEREAS, the National Federation of the Blind estimates
12 that as many as one in four households in which the parents are
13 blind have been visited by workers from child protection
14 services; and
15

16 WHEREAS, the safety of children must be balanced with
17 respect for differences in religion, culture, ethnicity, race,
18 disability, and sexual orientation; and
19

20 WHEREAS, blindness itself does not preclude a parent's
21 ability to raise kids; and
22

23 WHEREAS, blind parents use alternative techniques, which
24 are variations on methods that are based on touch and hearing
25 rather than sight, to accomplish some tasks; and

27 WHEREAS, there is research showing that children of blind
28 parents can perform better, on average, than those with sighted
29 parents in certain aspects; and

31 WHEREAS, thousands of blind parents have raised healthy
32 children who have grown into responsible, productive adults;
33 now, therefore,

2 BE IT RESOLVED by the House of Representatives of the
3 Twenty-ninth Legislature of the State of Hawaii, Regular Session
4 of 2018, that the Hawaii State Judiciary and Department of Human
5 Services are requested to not use:

7 (1) A parent's blindness as a basis for denial or
8 restriction of visitation or custody in family or
9 dependency law cases when the visitation or custody is
10 determined to be in the best interest of the child;
11
12 (2) A prospective parent's blindness as a basis for the
13 prospective parent's denial of participation in public
14 or private adoption when the adoption is determined to
15 be in the best interest of the child; or
16
17 (3) An individual's blindness as a basis for denial of
18 foster care or guardianship when the appointment is
19 determined to be in the best interest of the child;

22 BE IT FURTHER RESOLVED that if a parent or prospective
23 parent's blindness is alleged to have a detrimental impact on a
24 child, the Hawaii State Judiciary and Department of Human
25 Services are requested to:

27 (1) Place the burden of proof on the party raising the
28 allegation by requesting evidence that the behaviors
29 are endangering or will likely endanger the health,
30 safety, or welfare of the child; and

32 (2) Provide the blind parent or prospective parent the
33 opportunity to demonstrate how the implementation of
34 supportive parenting services can alleviate any
35 concerns that have been raised; and
