Your Committee on Finance, to which was referred H.B. No. 932
entitled:

"A BILL FOR AN ACT RELATING TO TAXATION,"

begs leave to report as follows:

The purpose of this measure is to provide tax relief to low-
income taxpayers by:

- (1) Gradually increasing the credit amounts and amending the
income brackets of the refundable food/excise tax
credit; and
- (2) Repealing the sunset date of the food/excise tax credit.

The Office of Hawaiian Affairs, Hawaii Appleseed Center for
Law and Economic Justice, Hawaii Women's Coalition, Catholic
Charities Hawaii, IMUAlliance, and one individual testified in
support of this measure. The Department of Taxation, Tax
Foundation of Hawaii, and Parents and Children Together commented
on this measure.


Your Committee has amended this measure by changing its
