Status

RELATING TO LIFEGUARDS.
Appropriates \$1,000,000 to the Department of Land and Natural Resources to hire lifeguards to monitor state and county beach parks.

DECISION MAKING TO FOLLOW

WEB: For testimony less than 20MB in size, transmit from <http://www.capitol.hawaii.gov/submittestimony.aspx>.


Testimony submitted will be placed on the legislative website. This public posting of testimony on the website should be considered when including personal information in your testimony.
