<u>HB 2017, HD1</u> <u>(HSCR58-18)</u> <u>Status</u>	RELATING TO AGRICULTURAL LANDS. Expands the definition of "agricultural lands" as it relates to an agricultural land owner's liability for injury, death, loss, or damage suffered by a trespasser, to include farm lands that are four acres or less and generate an unspecified amount of annual profit. (HB2017 HD1)	AGR, WAL, JUD
<u>HB 2564</u> <u>Status</u>	RELATING TO GOVERNMENT. Provides that the Board of Land and Natural Resources and Commission on Water Resource Management shall not conduct contested case hearings, and counties shall not conduct contested case hearings regarding disputes over land use, but that decisions and disputes may be contested and adjudicated in circuit court. Effective 7/1/2018.	WAL, JUD
<u>HB 2198</u> <u>Status</u>	RELATING TO WATERSHEDS. Establishes the watershed task force to define the term "watershed". Appropriates moneys.	WAL, FIN
<u>HB 2443</u> <u>Status</u>	RELATING TO AN ACCESSIBLE PLAYGROUNDS PILOT PROGRAM FOR DISABLED CHILDREN. Establishes a 3-year accessible playgrounds pilot program under DAGS. Requires a report to the legislature. Appropriates moneys.	WAL, FIN
<u>HB 2212</u> <u>Status</u>	RELATING TO OFFENSES AGAINST PUBLIC ADMINISTRATION. Establishes the offense of obstructing county real property zoning enforcement operations. Makes the offense a class C felony.	WAL, JUD



<u>HB 2358, HD1</u> <u>(HSCR47-18)</u> <u>Status</u>	RELATING TO PUBLIC LANDS. Exempts lands to which Hawaii Public Housing Authority holds title from the definition of "public lands" in chapter 171, HRS.	HSG, WAL, FIN
<u>HB 2101</u> <u>Status</u>	RELATING TO THE HAWAII ASSOCIATION OF CONSERVATION DISTRICTS. Makes an appropriation to the Department of Land and Natural Resources for the operational expenses and staffing costs of the Hawaii Association of Conservation Districts.	WAL, FIN
<u>HB 2222</u> <u>Status</u>	RELATING TO CRIMINAL TRESPASS. Amends the penalty for criminal trespass onto public parks and recreational grounds. Requires law enforcement officers to provide homeless individuals who trespass onto public parks and recreational grounds with information regarding homeless shelters, services, facilities, and safe zones.	WAL, JUD
<u>HB 2592</u> <u>Status</u>	RELATING TO WATER. Establishes a working group within the Department of the Attorney General to assess the viability and constitutionality of using tax increment financing on the county level as a means of incentivizing water-related infrastructure projects.	WAL, FIN

DECISION MAKING TO FOLLOW

Persons wishing to offer comments should submit testimony at least 24 hours prior to the hearing. Testimony should indicate:

- Testifier's name with position/title and organization;
- The Committee(s) to which the comments are directed;
- The date and time of the hearing; and
- Measure number.

While every effort will be made to incorporate all testimony received, materials received on the day of the hearing or improperly identified or directed, may be distributed to the Committee after the hearing.

Submit testimony in ONE of the following ways:

PAPER: 10 copies (including an original) to Room 305 in the State Capitol;

FAX: For testimony less than 5 pages in length, transmit to 808-586-8484 (Oahu) or 1-800-535-3859 (for Neighbor Islander without a computer to submit testimony through e-mail or the Web); or


WEB: For testimony less than 20MB in size, transmit from <http://www.capitol.hawaii.gov/submittestimony.aspx>.

Testimony submitted will be placed on the legislative website. This public posting of testimony on the website should be considered when including personal information in your testimony.

If during the course of the hearing it appears that there will not be sufficient time to allow everyone to be heard, the chairperson reserves the right to limit the remaining testifiers to three-minutes. This three-minute policy will be enforced to ensure fairness and adequate consideration to all bills.
