- (6) Name three qualities that best describe you and how these qualities will benefit the Board.

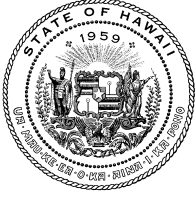
- a. Volunteer – I value my role as a volunteer as one aspect of maintaining my own good health.

2 professional organizations such as the American Academy of Nurse Practitioners, American
3 Nurses Association, and American Public Health Association. Given her background and
4 experience, Dr. Jamie Boyd will be an added resource to the Windward Oahu Subarea Health
5 Planning Council.
