b. Problem-solver: I enjoy solving problems.

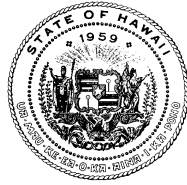
c. Innovative: I think outside the box.


