I am writing in support of the nomination of Gerald Silva to the Hawaii Advisory Council on Emergency Management. My name is Ji Sook “Lisa” Kim, Administrator of the Cable Television Division of the Department of Commerce and Consumer Affairs (DCCA), and I offer, in my personal capacity, testimony in **strong support** of G.M. Nos. 588 and 589.

I have had the privilege of knowing Mr. Silva since 2014 when I joined the Cable Television Division of the DCCA as a staff attorney and he was serving as the Oahu at-large member of the Cable Advisory Committee (CAC) of the DCCA. The CAC offers advice and insight to the Director of the DCCA concerning important cable matters. As a member, Mr. Silva was always conscientious, prepared, and fully engaged, and was known to never have missed a CAC meeting.
