Purpose of Measure: Submitting for consideration and confirmation to the Early Learning Board, Gubernatorial Nominee, Cherilyn Shiinoki, for a term to expire June 30, 2020.

EXECUTIVE OFFICE ON EARLY LEARNING'S POSITION: The Executive Office on Early Learning (EOEL) strongly supports the confirmation of Ms. Cherilyn Shiinoki to the Early Learning Board, for a second term to expire June 30, 2020.
