# A BILL FOR AN ACT

RELATING TO GLASS CONTAINER RECOVERY.

**BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:**

1 SECTION 1. Section 36-27, Hawaii Revised Statutes, is  
2 amended by amending subsection (a) to read as follows:

3 "(a) Except as provided in this section, and  
4 notwithstanding any other law to the contrary, from time to  
5 time, the director of finance, for the purpose of defraying the  
6 prorated estimate of central service expenses of government in  
7 relation to all special funds, except the:

9 under section 302A-1310;
- 10 (2) School cafeteria special funds of the department of  
11 education;
- 12 (3) Special funds of the University of Hawaii;

11 shall deduct five per cent of all receipts of all other special  
12 funds, which deduction shall be transferred to the general fund  
13 of the State and become general realizations of the State. All  
14 officers of the State and other persons having power to allocate  
15 or disburse any special funds shall cooperate with the director  
16 in effecting these transfers. To determine the proper revenue  
17 base upon which the central service assessment is to be  
18 calculated, the director shall adopt rules pursuant to chapter  
19 91 for the purpose of suspending or limiting the application of  
20 the central service assessment of any fund. No later than  
21 twenty days prior to the convening of each regular session of



1 the legislature, the director shall report all central service  
2 assessments made during the preceding fiscal year."

3 SECTION 2. Chapter 342G, part VII, Hawaii Revised  
4 Statutes, is repealed.

5 SECTION 3. The director of finance shall abolish the  
6 special account in the environmental management fund established  
7 pursuant to section 342G-84, Hawaii Revised Statutes, and shall  
8 transfer any unencumbered balance remaining, as of June 30,  
9 2019, to the credit of the general fund.

10 SECTION 4. This Act shall take effect on July 1, 2100.
