requirement that a Hawaiian Center and Museum of Hawaiian Music  
and Dance that is funded through Transient Accommodations Tax

Productions, LLC; and O'ahu County Committee on Legislative  
Priorities of the Democratic Party of Hawai'i supported this  
measure.


Your Committee has amended this measure by changing its
