Your Committees on Health and Human Services & Homelessness,
to which was referred S.B. No. 1237, S.D. 1, entitled:

"A BILL FOR AN ACT RELATING TO HEALTH,"

beg leave to report as follows:

The purpose of this measure is to require health insurers who provide Medicare Advantage (Medicare Part C) health benefit plans to Hawaii residents to submit administrative data to the State Health Planning and Development Agency for inclusion in the All-Payer Claims Database.

The Department of Health, Department of Commerce and Consumer Affairs, State Health Planning and Development Agency, Hawaii Employer-Union Health Benefits Trust Fund, Executive Office on Aging, and University of Hawai'i at Mānoa College of Social Sciences testified in support of this measure.

Your Committees have amended this measure by:

- (1) Changing the effective date to July 1, 2050, to promote further discussion; and
- (2) Making technical, nonsubstantive amendments for clarity, consistency, and style.



Your Committees find that this measure serves only to expand the data collected in the All-Payer Claims Database to include administrative data for Medicare Advantage health benefit plans.
