# A BILL FOR AN ACT

RELATED TO NON-GENERAL FUNDS.

**BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:**

1           SECTION 1. The purpose and intent of this Act is to repeal  
2 and abolish certain non-general funds and accounts pursuant to  
3 the recommendations by the auditor in auditor's report no. 18-21  
4 and to transfer the unencumbered balances to the general fund.

5           SECTION 2. The Captain Cook memorial fund, repealed by Act  
6 147, Session Laws of Hawaii 2015, is abolished and any remaining  
7 unencumbered balance shall lapse to the general fund.

8           SECTION 3. The custodial services special fund  
9 administratively established in 2003 is abolished and any  
10 remaining unencumbered balance shall lapse to the general fund.

11           SECTION 4. The donations for voter registration drive  
12 trust account administratively established in 1984 is abolished  
13 and any remaining unencumbered balance shall lapse to the  
14 general fund.

15           SECTION 5. The information technology trust fund  
16 administratively established in 2014 is abolished and any  
17 remaining unencumbered balance shall lapse to the general fund.







