
A BILL FOR AN ACT

RELATING TO THE DEPARTMENT OF HAWAIIAN HOME LANDS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. There is appropriated out of the general
2 revenues of the State of Hawaii the sum of \$487,968 or so much
3 thereof as may be necessary for fiscal year 2019-2020 to be
4 deposited into the cesspool compliance grant program special
5 fund.

6 SECTION 2. There is appropriated out of the cesspool
7 compliance grant program special fund the sum of \$243,984 or so
8 much thereof as may be necessary for fiscal year 2019-2020 and
9 the same sum or so much thereof as may be necessary for fiscal
10 year 2020-2021 to implement the cesspool compliance grant
11 program.

12 SECTION 3. The director of finance is authorized to issue
13 general obligation bonds in the sum of \$25,000,000 or so much
14 thereof as may be necessary and the same sum or so much thereof
15 as may be necessary is appropriated for fiscal year 2019-2020
16 for the purpose of capital improvement projects including lot
17 development, loans, and rehabilitation projects.



1 SECTION 4. The director of finance is authorized to issue
2 general obligation bonds in the sum of \$25,000,000 or so much
3 thereof as may be necessary and the same sum or so much thereof
4 as may be necessary is appropriated for fiscal year 2020-2021
5 for the purpose of capital improvement projects including lot
6 development, loans, and rehabilitation projects.

7 SECTION 5. The appropriation made for the capital
8 improvement projects authorized by sections 3 and 4 of this Act
9 shall not lapse at the end of the fiscal biennium for which the
10 appropriation is made; provided that all moneys from the
11 appropriation unencumbered as of June 30, 2022, shall lapse as
12 of that date.

13 SECTION 6. There is appropriated out of the general
14 revenues of the State of Hawaii the sum of \$ or so
15 much thereof as may be necessary for fiscal year 2019-2020 and
16 the same sum or so much thereof as may be necessary for fiscal
17 year 2020-2021 to assist the department of Hawaiian home lands
18 with building homes, infrastructure, capital improvement
19 projects, operating and administrative costs, fringe, and other
20 needs and priorities.



1 SECTION 7. The sums appropriated by this Act shall be
2 expended by the department of Hawaiian home lands for the
3 purposes of this Act.

4 SECTION 8. This Act shall take effect on July 1, 2019.

Description:

Appropriates funds for deposit into and out of the cesspool compliance grant program special fund to implement the cesspool compliance grant program. Authorizes the issuance of general obligation bonds for capital improvement projects including lot development, loans, and rehabilitation projects. Appropriates an unspecified amount for building homes, infrastructure, capital improvement projects, operating and administrative costs, fringe, and other needs and priorities. (SD1)
