<u>HB 273</u> <u>Status</u>	RELATING TO PRIVACY NOTICE FOR INSURANCE. Establishes an exemption for insurers to the required annual privacy notice to customers under certain circumstances.	CPC/JUD
<u>HB 295</u> <u>Status</u>	RELATING TO DOMESTIC ABUSE. Amends the definition of domestic abuse under Hawaii's insurance laws and domestic abuse protective orders to include emotional abuse between family or household members. Defines emotional abuse.	CPC/JUD
<u>HB 253, HD1</u> <u>(HSCR371)</u> <u>Status</u>	RELATING TO MOTOR VEHICLES. Prohibits a person from intentionally or knowingly manufacturing, importing, installing, reinstalling, distributing, selling, or offering for sale any counterfeit supplemental restraint system component, nonfunctional airbag, or airbag that does not meet federal safety requirements. Prohibits a person from intentionally or knowingly selling, offering for sale, installing, or reinstalling in a motor vehicle any device that causes the motor vehicle's diagnostic systems to fail to warn that the motor vehicle is equipped with a counterfeit supplemental restraint system component or nonfunctional airbag or that no airbag is installed, as applicable. HB 1166, HD1  
(HSCR364)  
Status

RELATING TO CONSUMER PROTECTION.  
Caps the service charges for a primary and secondary ticket seller. Requires website operators to guarantee refunds in certain circumstances and disclose that the website is not the primary ticket seller. Prohibits speculative tickets and the usage of bots. Makes conforming amendments. (HB1166 HD1)

HB 797  
Status

RELATING TO TELECOMMUNICATIONS CARRIERS.  
Requires telecommunications carriers to block calls to residential phone lines and personal mobile phone lines made from telephone numbers that do not match any of the telephone numbers of certain excepted entities as a means to curb scam calls.

DECISION MAKING TO FOLLOW

Persons wishing to offer comments should submit testimony at least 24 hours prior to the hearing. Testimony should indicate:

- Testifier's name with position/title and organization;
- The Committee(s) to which the comments are directed;
- The date and time of the hearing; and
- Measure number.

While every effort will be made to incorporate all testimony received, materials received on the day of the hearing or improperly identified or directed, may be distributed to the Committee after the hearing.

Submit testimony in ONE of the following ways:

PAPER: 25 copies (including an original) to Room 426 in the State Capitol;

FAX: For testimony less than 5 pages in length, transmit to 808-586-6221 (Oahu) or 1-800-535-3859 (for Neighbor Islander without a computer to submit testimony through the website); or

WEB: For testimony less than 20MB in size, transmit from <http://www.capitol.hawaii.gov/submittestimony.aspx>.

Testimony submitted will be placed on the legislative website. This public posting of testimony on the website should be considered when including personal information in your testimony.
