SB279 Status and Testimony	RELATING TO THE DEPARTMENT OF HUMAN SERVICES. Appropriates funds for the Department of Human Services. Appropriates funds. Effective 7/1/2050.	HMS, WAM
SB474 Status and Testimony	RELATING TO THE DEPARTMENT OF HUMAN SERVICES. Appropriates funds for operating expenses of the department of human resources.	HMS, WAM
SB475 Status and Testimony	RELATING TO THE DEPARTMENT OF HUMAN SERVICES. Appropriates funds for capital improvement projects of the department of human services.	HMS, WAM
SB449 Status and Testimony	RELATING TO CHILDREN. <u>Establishes in the department of the attorney general a child abuse investigation unit. Allows the department of the attorney general to intervene in adjudications in family court. Enacts the Uniform Child Witness Testimony by Alternative Methods Act, which authorizes courts to allow for children to testify in a place other than an open forum or away from the finder of fact, court, or parties. Requires the court and the prosecution to take appropriate action to ensure a prompt trial in order to minimize the length of time a child abuse victim or minor witness must endure the stress of the child's involvement in the proceedings.</u>	<u>HMS, JDC/WAM</u> [Measure added on 2/1/2019]
