HB 725
Status

RELATING TO STANDARDIZED TESTING.
Limits public school students' participation in standardized tests and provides notice to students and parents or guardians of the opportunity to opt out of standardized tests. Prohibits use of standardized test scores for the evaluation of teachers and educational officers.

Status

RELATING TO COLLECTIVE BARGAINING.
Establishes a collective bargaining unit for graduate student assistants employed by the University of Hawaii.

DECISION MAKING TO FOLLOW




