

10 Fire Department in Kauai and as EMS Educational Coordinator-Kauai County for Kapiolani
11 Community College-Department of Emergency Medical Services. She used to be the Medical
12 Coordinator and Flight Paramedic/Educator for AMR Air Hawaii and a Paramedic for the City
13 and County of Honolulu Department of Emergency Medical Services.

14 Ms. Kelekoma obtained her Associates Degree in Paramedicine from the University of
15 Hawaii Kapiolani Community College. She is a nationally registered paramedic, a certified
16 flight paramedic and an NAEMT affiliate faculty for the State of Hawaii, among others.

1 She has over 15 years of experience in every aspect of emergency medical service,
2 ground 911 response, critical care flight transports, and education. Given her experience and
3 passion for the promotion of health and well-being of the community in Hawaii and Kauai
4 County, Ms. Jillian Kelekoma would be a valuable addition to the Kauai County Subarea
5 Health Planning Council.


Chair Baker and members of the CPH committee,
