Your Committee on Hawaiian Affairs, to which was referred  
S.B. No. 43 entitled:

"A BILL FOR AN ACT RELATING TO HAWAIIAN AFFAIRS,"

begs leave to report as follows:

The purpose and intent of this measure is to amend the law  
relating to Hawaiian affairs.

Prior to the hearing on this measure, your Committee posted  
and made available for public review a proposed S.D. 1, which  
amends this measure by deleting its contents and replacing it with  
language to create a statewide supplementary certification board  
for the practitioners of traditional native Hawaiian healing arts,  
where practitioners may be certified to practice.

Your Committee has amended this measure by:

- (1) Adopting the proposed S.D. 1; and
- (2) Making technical, nonsubstantive amendments for the  
purposes of clarity and consistency.

As affirmed by the record of votes of the members of your  
Committee on Hawaiian Affairs that is attached to this report,  
your Committee is in accord with the intent and purpose of S.B.  
No. 43, as amended herein, and recommends that it be recommitted



to your Committee on Hawaiian Affairs, in the form attached hereto as S.B. No. 43, S.D. 1, for further consideration.
