The purpose and intent of this measure is to request the
Department of Education to submit a report of the Legislature on
the implementation of the amended chapters 19 and 89 of Title 8,
Hawaii Administrative Rules.


Your Committee received testimony in support of this measure
from the Hawaii Youth Services Network, Hawaii Women's Coalition,
and American Association of University Women.

Your Committee finds that Hawaii reports a low rate of school
violence in every area except bullying. The number of youth in
Hawaii who are afraid to go to school or have missed school due to
bullying is substantially much higher than the national average.
Your Committee further finds that this measure will help reduce
bullying and cyberbullying by fostering a positive school climate
and facilitating the effective implementation of an evidence-based
social and emotional learning program.



As affirmed by the record of votes of the members of your Committee on Education that is attached to this report, your Committee concurs with the intent and purpose of S.R. No. 8 and recommends that it be referred to your Committee on Judiciary.


