## HOUSE RESOLUTION

URGING THE DEPARTMENT OF LAND AND NATURAL RESOURCES TO ADDRESS MICROPLASTICS BY DESIGNATING PERSONNEL, IMPLEMENTING TECHNOLOGY, AND ESTABLISHING A PILOT PROJECT AT KAILUA BEACH PARK TO DEPLOY AND TEST NEW SAND-CLEANING TECHNOLOGIES FOR STATEWIDE USE.

1 WHEREAS, Hawaii is known worldwide for its beautiful  
2 beaches and rich ocean habitat that have provided residents with  
3 sustenance, recreational opportunities, and other resources for  
4 generations; and

5  
6 WHEREAS, Hawaii's location in the center of the Pacific  
7 Ocean, just east of the Great Pacific Garbage Patch, ensures  
8 that countless tons of marine debris from around the world,  
9 including very small pieces of plastic particles known as  
10 microplastics, wash up on the State's beaches; and

11  
12 WHEREAS, the health of our beaches, ocean resources, and  
13 fragile marine ecosystems are seriously threatened by pollution  
14 from microplastics; and

15  
16 WHEREAS, scientists have documented at least six hundred  
17 ninety species of wildlife that have been impacted by the  
18 ingestion of microplastics, including the beloved green sea  
19 turtles, which lay their eggs on the State's beaches; and

20  
21 WHEREAS, plankton, invertebrates, fish, sea birds, and  
22 marine mammals are also all known to absorb, ingest, or  
23 otherwise uptake microplastics; and

24  
25 WHEREAS, the microplastics absorbed or ingested by these  
26 organisms eventually impact humans as the microplastics make  
27 their way up the food chain; and

1 WHEREAS, because microplastics are less than five  
2 millimeters in size, it is extremely difficult to remove them  
3 from the environment; and  
4

5 WHEREAS, although microplastics are deposited at beaches  
6 statewide, Kailua Beach on the island of Oahu has been  
7 especially prone to microplastic pollution due to onshore winds  
8 and other natural conditions; and  
9

10 WHEREAS, despite regular beach cleanups by volunteer  
11 groups, including a recent clean-up effort that resulted in the  
12 removal of five thousand pounds of plastics, the ocean  
13 continually deposits new plastic debris onto Kailua Beach; and  
14

15 WHEREAS, Kailua Beach has consistently been voted as one of  
16 the best beaches in the United States; however, the continued  
17 influx of plastics onto Kailua Beach may threaten the beach's  
18 reputation and status as a gathering place for residents and  
19 visitors; and  
20

21 WHEREAS, researchers have been developing new technologies  
22 to remove microplastics from the coastline, including one used  
23 in a recent pilot project conducted by the University of Hawaii  
24 at Hilo, the Hawaii Wildlife Fund, and engineering students from  
25 the Université de Sherbrooke in Québec, Canada, that tested a  
26 machine designed to filter microplastics from sand at Kamilo  
27 Point on Hawaii Island; and  
28

29 WHEREAS, the State must support efforts like the pilot  
30 program at Kamilo Point in order to find viable solutions to  
31 protect our beaches from microplastic pollution, with the  
32 ultimate goal of deploying these solutions statewide; now,  
33 therefore,  
34

35 BE IT RESOLVED by the House of Representatives of the  
36 Thirtieth Legislature of the State of Hawaii, Regular Session of  
37 2020, that the Department of Land and Natural Resources is urged  
38 to specifically address microplastics by designating personnel  
39 to address the issue and implementing technology that removes  
40 microplastic debris from the sand and ocean water; and

1 BE IT FURTHER RESOLVED that the Department of Land and  
 2 Natural Resources is urged to develop and implement a pilot  
 3 program at Kailua Beach, which has been subject to  
 4 disproportionately large sums of microplastics, to deploy and  
 5 test new sand-cleaning technologies for statewide use; and  
 6

7 BE IT FURTHER RESOLVED that the Department of Land and  
 8 Natural Resources is requested to submit a report of its  
 9 findings and recommendations, including any proposed  
 10 legislation, to the Legislature no later than twenty days prior  
 11 to the convening of the Regular Session of 2021; and  
 12

13 BE IT FURTHER RESOLVED that certified copies of this  
 14 Resolution be transmitted to the Chairperson of the Board of  
 15 Land and Natural Resources and Director of the Department of  
 16 Parks and Recreation of the City and County of Honolulu.
