FLOOR AMENDMENT NO. 2 Date MAR 03 2020

TO: Senate Bill No. 3080, S.D. 2

SECTION 1. Senate Bill No. 3080, S.D. 2, is amended by deleting the existing Section 2 and replacing it with the following:

"SECTION 2. Act 38, Session Laws of Hawaii 2019, is amended by amending part II to read as follows:

"PART II. PROGRAM APPROPRIATIONS

SECTION 3. The following sums, or so much thereof as may be sufficient to accomplish the purposes and programs designated herein, are appropriated or authorized from the sources of funding specified to the judiciary for the fiscal biennium beginning July 1, 2019, and ending June 30, 2021. The total expenditures and the number of permanent and temporary positions established in each fiscal year of the fiscal biennium shall not exceed the sums and the position ceilings indicated for each year, except as provided in this Act.

"PART IV. CAPITAL IMPROVEMENT PROJECTS

SECTION 8. The sum of [~~\$9,355,000~~] \$23,349,000 appropriated or authorized in part II of this Act for capital improvement projects shall be expended by the judiciary for the projects listed below; provided that several related or similar projects may be combined into a single project, if a combination is advantageous or convenient for implementation; provided further that the total cost of the projects thus combined shall not exceed the total of the sums specified for the projects separately. The amount after each cost element and the total funding for each project listed in this part are in thousands of dollars.


