
A BILL FOR AN ACT

RELATING TO LEGAL SERVICES FOR LOW-INCOME IMMIGRANTS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that a large number of
2 immigrants are constantly seeking to continue or obtain legal
3 status and citizenship in the United States. However, the
4 immigration court process is highly complex, which may be
5 intimidating or overwhelming for immigrants who may struggle
6 with navigating a different culture and language. Many
7 immigrants face barriers to obtaining legal status and
8 citizenship. Low-income immigrants often lack the resources to
9 obtain legal representation, which may have a profound impact on
10 the immigrants' ability to receive a fair hearing.

11 The legislature further finds that Hawaii has always
12 welcomed people of all backgrounds, nationalities, and
13 ethnicities. According to the 2017 American Immigration Council
14 Fact Sheet, nearly eighteen per cent of Hawaii residents are
15 immigrants, while more than one in seven residents is a
16 native-born United States citizen with at least one immigrant
17 parent. Immigrants are an integral part of Hawaii's diverse,



1 multicultural community and make extensive contributions to the
2 State.

3 Given the current political climate, a significant number
4 of low-income immigrants are at risk of being detained or
5 deported. Therefore, there are vital public policy reasons
6 behind providing legal counsel to immigrants in immigration
7 proceedings.

8 Accordingly, the purpose of this Act is to appropriate
9 funds to the department of labor and industrial relations,
10 office of community services, to contract with non-profit
11 providers to provide low-income immigrants with legal counsel to
12 assist and represent them in immigration proceedings and provide
13 assistance on immigrant status issues.

14 SECTION 2. There is appropriated out of the general
15 revenues of the State of Hawaii the sum of \$ or so
16 much thereof as may be necessary for fiscal year 2020-2021 for
17 the department of labor and industrial relations, office of
18 community services, to contract with non-profit providers to
19 provide low-income immigrants with legal counsel to assist and
20 represent them in immigration proceedings and provide assistance
21 on immigrant status issues; provided that the office of



1 community services may retain up to ten per cent of the
2 appropriation for its administrative costs in entering into and
3 overseeing the contracts.

4 The sum appropriated shall be expended by the department of
5 labor and industrial relations for the purposes of this Act.

6 SECTION 3. This Act shall take effect on July 1, 2050.
