RELATING TO PUBLIC EMPLOYMENT COST ITEMS.

**BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:**

1 PART I

1 SECTION 14. Funds appropriated or authorized by this Act  
2 that are not expended or encumbered by June 30, 2022, and  
3 June 30, 2023, of the respective fiscal years, shall lapse as of  
4 those dates.

5 SECTION 15. This Act shall take effect on December 25,  
6 2040.
