**BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:**

 9 shall be paid wholly or proportionately, as the case may be,  
 10 from the respective funds.

11           SECTION 14. Funds appropriated or authorized by this Act  
 12 that are not expended or encumbered by June 30, 2022, and June  
 13 30, 2023, of the respective fiscal years, shall lapse as of  
 14 those dates.

15           SECTION 15. This Act shall take effect on July 1, 2021.
