RELATING TO PUBLIC EMPLOYMENT COST ITEMS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 22. The fiscal year 2021-2022 appropriations under
2 this Act shall not lapse until the end of fiscal biennium 2021-
3 2023; provided that funds appropriated or authorized by this Act
4 that are not expended or encumbered by June 30, 2023, shall
5 lapse as of that date.

6 SECTION 23. This Act shall take effect on December 25,
7 2040.
