Your Committee on Finance, to which was referred H.B.
No. 433, H.D. 1, entitled:

"A BILL FOR AN ACT RELATING TO CLIMATE CHANGE MITIGATION,"

begs leave to report as follows:

The purpose of this measure is to:

- (1) Assess a climate change mitigation impact fee on every customer who rents, leases, or utilizes a rental motor vehicle;
- (2) Establish the Climate Change Mitigation Special Fund;
and
- (3) Designate the uses of the monies in the Climate Change Mitigation Special Fund.

Your Committee received testimony in support of this measure from the Hawaii Climate Change Mitigation and Adaption Commission; Kupu; The Trust for Public Land; Blue Planet Foundation; Keiko Conservation; Climate Protectors Hawaii; Imua Alliance; Hawaii Electric Vehicle Association; Surfrider Foundation, O'ahu Chapter; and numerous individuals. Your Committee received testimony in opposition to this measure from Enterprise Holdings and Avis Budget Group. Your Committee received comments on this measure


