Your Committee on Finance, to which was referred H.B.
No. 516, H.D. 1, entitled:

"A BILL FOR AN ACT RELATING TO SUSTAINABLE ELECTRONICS
MANAGEMENT,"

begs leave to report as follows:

The purpose of this measure is to promote electronics
stewardship and reduce electronic waste in the State by
establishing the Electronic Device and Television Donation Act to
require all persons receiving state funds and state financial
assistance to donate unnecessary but functioning electronic
devices to nonprofit organizations that will refurbish and
distribute the devices to eligible persons in the State.

Your Committee received testimony in support of this measure
from the Department of Education, Hawaiian Hope Org, and one
individual. Your Committee received comments on this measure from
the Department of Accounting and General Services and one
individual.

As affirmed by the record of votes of the members of your
Committee on Finance that is attached to this report, your
Committee is in accord with the intent and purpose of H.B.
No. 516, H.D. 1, and recommends that it pass Third Reading.
