Sir:

Your Committee on Consumer Protection & Commerce, to which was referred H.C.R. No. 23 entitled:

"HOUSE CONCURRENT RESOLUTION AUTHORIZING THE ISSUANCE OF A TERM, NON-EXCLUSIVE EASEMENT COVERING A PORTION OF STATE SUBMERGED LANDS AT WAIOHULI-KEOKEA HOMESTEADS, KIHEI, MAUI, FOR THE EXISTING SEAWALL, ROCK REVETMENT, AND CONCRETE STEPS, AND FOR USE, REPAIR, AND MAINTENANCE OF THE EXISTING IMPROVEMENTS CONSTRUCTED THEREON,"

begs leave to report as follows:

The purpose of this measure is to authorize the Board of Land and Natural Resources to issue a term, non-exclusive easement covering a portion of state submerged lands at Waiohuli-Keokea Homesteads, Kihei, Maui, for the existing seawall, rock revetment, and concrete steps, and for the use, repair, and maintenance of the existing improvements constructed thereon.

Your Committee received testimony in support of this measure from the Department of Land and Natural Resources.

Your Committee finds that the existing walkway fronting private property located in Waiohuli-Keokea, and spanning 668 square feet, encroaches onto state submerged lands. Your Committee further finds that the Department of Land and Natural Resources granted a 55-year non-exclusive easement to run with the land and to inure to the benefit of the abutting real property to

resolve the encroachment. This measure authorizes the granting of a term, non-exclusive easement, as required by state law, for the portion of identified state submerged lands in Waiohuli-Keokea that have been encroached upon by the seawall, rock revetment, and concrete steps, and for the use, repair, and maintenance of the existing improvements constructed thereon.


