Sir:

Your Committee on Public Safety, Intergovernmental, and  
Military Affairs, to which was referred S.B. No. 414 entitled:

"A BILL FOR AN ACT MAKING AN APPROPRIATION TO THE DEPARTMENT  
OF THE PROSECUTING ATTORNEY OF THE CITY AND COUNTY OF  
HONOLULU,"

begs leave to report as follows:

The purpose and intent of this measure is to appropriate  
funds to the Department of the Prosecuting Attorney of the City  
and County of Honolulu as a grant-in-aid for the career criminal  
prosecution unit.

Your Committee received testimony in support of this measure  
from the Department of the Prosecuting Attorney of the City and  
County of Honolulu, Office of the Prosecuting Attorney for the  
County of Hawai'i, and one individual.

Your Committee finds that a disproportionate number of  
serious crimes against the public are committed by a relatively  
small number of multiple and repeat-felony offenders, commonly  
known as "career criminals". Your Committee further finds that by  
their nature, career criminal prosecution cases are often labor  
intensive and require experienced and well-trained deputy  
prosecutors. This measure appropriates funds to staff the career  
criminal prosecution unit so that the prosecution of career  
criminals can be more effectively pursued.



As affirmed by the record of votes of the members of your Committee on Public Safety, Intergovernmental, and Military Affairs that is attached to this report, your Committee is in accord with the intent and purpose of S.B. No. 414 and recommends that it pass Second Reading and be referred to your Committee on Ways and Means.
