
A BILL FOR AN ACT

MAKING AN EMERGENCY APPROPRIATION TO THE OFFICE OF THE GOVERNOR
RELATING TO COVID-19 EXPENDITURES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. This Act is recommended by the governor for
2 immediate passage in accordance with section 9 of article VII of
3 the constitution of the State of Hawaii.

4 SECTION 2. The impact of the "SARS-CoV-2" virus and
5 resulting "coronavirus disease 2019" (COVID-19) has been
6 devastating to global, national, and state economies.

7 The Coronavirus Aid, Relief, and Economic Security Act
8 (CARES Act), Public Law 116-136, was enacted on March 27, 2020,
9 to address the extensive health and economic fallout of the
10 COVID-19 pandemic and provided federal funds to support the
11 State's COVID-19 relief efforts. With the expiration of federal
12 CARES Act funds, the State finds that additional funds are
13 needed to continue funding critical COVID-19 response programs
14 and activities for the remainder of fiscal year 2020-2021.

15 Accordingly, the purpose of this Act is to appropriate
16 funds for the purpose of COVID-19 response activities and

1 provide transparency and accountability for the use of those
2 funds.

3 SECTION 3. There is appropriated out of the general
4 revenues of the State of Hawaii the sum of \$20,000,000 or so
5 much thereof as may be necessary for fiscal year 2020-2021 to be
6 used as a contingency fund by the office of the governor to
7 supplement the continuation of COVID-19 response related
8 programs and activities.

9 The sum appropriated shall be expended by the office of the
10 governor for the purposes of this Act.

11 SECTION 4. Provided that the governor is authorized to
12 transfer funds appropriated by this Act among all executive
13 agencies as may be deemed necessary; and provided further that
14 the governor is authorized to transfer funds in excess of what
15 is needed for each expending agency from other emergency
16 appropriation acts relating to COVID-19 expenditures for fiscal
17 year 2020-2021 to the contingency fund as deemed necessary by
18 the governor for the purposes of this Act.

19 SECTION 5. This Act shall take effect upon its approval;
20 provided that all funds appropriated pursuant to this Act that
21 are unallotted or unencumbered shall lapse as of June 30, 2022.

JUSTIFICATION SHEET

DEPARTMENT: Office of the Governor

TITLE: A BILL FOR AN ACT MAKING AN EMERGENCY APPROPRIATION TO THE OFFICE OF THE GOVERNOR RELATING TO COVID-19 EXPENDITURES.

PURPOSE: To provide an emergency appropriation to the Office of the Governor for fiscal year 2020-2021 to continue funding for various COVID-19 response related programs and activities.

MEANS: General fund appropriation to the Office of the Governor.

JUSTIFICATION: The COVID-19 pandemic has been devastating to global, national, and state economies. Federal funds appropriated to the State of Hawaii by the Coronavirus Aid, Relief, and Economic Security Act (CARES Act), Public Law 116-136, provided funding to implement and administer various COVID-19 related response, relief, and mitigation programs and activities.

The State finds that additional funds from the general revenues of the State are needed to continue funding critical COVID-19 response programs and activities.

Funding will be used for vital public health and safety, public welfare, economic recovery, and other appropriate COVID-19 response activities.

Impact on the public: This measure will have significant direct and indirect impacts on the public. The programs and activities funded by this measure will be used for such activities as continuation of: the State's Safe Travels Hawaii Program; COVID-19 related medical surge staffing; funding for vaccination and immunization implementation and administration; personal protective

equipment; and other public services as deemed necessary to respond to the COVID-19 pandemic.

Impact on the department and other agencies:
Departments are currently performing the activities described herein based on subject matter and program/activity jurisdiction but will not be able to continue to do so without continued funding.

This appropriation to the Office of the Governor will serve as a contingency to fund to supplement COVID-19 response related programs and activities in all executive agencies as needed.

GENERAL FUND: Total general fund impact of this measure is \$20,000,000 for fiscal year 2020-2021.

OTHER FUNDS: None.

PPBS PROGRAM DESIGNATION: GOV 100, Office of the Governor.

OTHER AFFECTED AGENCIES: All executive branch departments and agencies.

EFFECTIVE DATE: Upon approval.
