SENATE CONCURRENT RESOLUTION

REQUESTING THE DEPARTMENT OF HAWAIIAN HOME LANDS, IN CONJUNCTION WITH THE COUNTY OF HAWAII DEPARTMENT OF WATER SUPPLY, TO PROVIDE A PROGRESS REPORT REGARDING THE DEVELOPMENT OF THE KA'U WATER SYSTEM.

1 WHEREAS, Act 49, Session Laws of Hawaii 2017, allocated,
2 among other things, \$1,500,000 in general obligation bonds for
3 the plans, design, and construction for the development of the
4 Ka'u water system; and

5
6 WHEREAS, phase one of the project includes the design and
7 construction of a one hundred thousand gallon water storage tank
8 and appurtenances on Hawaiian home lands; and

9
10 WHEREAS, the Hawaiian Homes Commission approved \$500,000 in
11 trust funds for construction; and

13 WHEREAS, the estimated advertisement for bids was expected
14 to occur in early 2020; and

15
16 WHEREAS, it is understood that the Department of Hawaiian
17 Home Lands invited twenty-five pastoral lessees to discuss the
18 water needs for each lot and supplemental water availability;
19 and

21 WHEREAS, it is expected that phase two of the project will
22 include repair and replacement of pressure reducing valve
23 stations; and

25 WHEREAS, it is further expected that phase three of the
26 project will include the relocation of existing waterlines from
27 within leased lots to the South Point Road right-of-way,
28 installation of new water meters, fire protection, and the
29 subdivision of twenty-five pastoral lots; and

1 WHEREAS, because of the complexities and future costs of
2 the Ka'u water system project, it would be prudent for the
3 Legislature to receive an update on the progress of the project;
4 now, therefore,

5
6 BE IT RESOLVED by the Senate of the Thirty-first
7 Legislature of the State of Hawaii, Regular Session of 2021, the
8 House of Representatives concurring, that the Department of
9 Hawaiian Home Lands, in conjunction with the County of Hawai'i
10 Department of Water Supply, is requested to provide a progress
11 report regarding the development of the Ka'u water system; and

13 BE IT FURTHER RESOLVED that the Department of Hawaiian Home
14 Lands is requested to submit the progress report to the
15 Legislature by June 30, 2021; and

17 BE IT FURTHER RESOLVED that certified copies of this
18 Concurrent Resolution be transmitted to the Governor,
19 Chairperson of the Hawaiian Homes Commission, and Manager of the
20 County of Hawai'i Department of Water Supply.
