RELATING TO ENERGY

House Bill No. 1513, H.D. 1, S.D. 1: establishes a two-year Alternative Energy Research and Development Program under the Department of Business, Economic Development and Tourism to promote alternative energy research and development in Hawaii; establishes the Alternate Energy Research and Development Revolving Fund; and appropriates an indeterminate amount in general funds in FY 16 and in FY 17 to be deposited into the revolving fund to be used for the purpose of the two-year pilot program.

As a matter of general policy, the Department of Budget and Finance does not support the creation of any special fund which does not meet the requirements of Section 37-52.3, HRS. Special or revolving funds should: 1) reflect a clear nexus between the benefits sought and charges made upon the users or beneficiaries of the program; 2) provide an appropriate means of financing for the program or activity; and 3) demonstrate the capacity to be financially self-sustaining. In regards to House Bill No. 1513, H.D. 1, S.D. 1, it is difficult to determine whether there is a clear nexus between the benefits sought and the source of funding, and whether the fund will be self-sustaining.

I encourage the Legislature to review the fiscal and operational plan for this program to ensure that it does conform to the requirements of Section 37-52.3, HRS.
