Chair Luke, Vice Chair Nishimoto, and Members of the Committee on Finance.

The High Technology Development Corporation (HTDC) **supports the intent** of HB1513 HD1 relating to energy.

As part of HTDC's vision to create 80,000 new innovation jobs in Hawaii earning \$80,000 or more by 2030, HTDC supports initiatives aimed at promoting technology and innovation jobs. HTDC's Hawaii Small Business Innovation Research matching grant program is a successful model which piggybacks on the vetting process of the highly competitive federal grant program. The program has resulted in 20 federal dollars awarded to Hawaii companies for every state dollar. The program described in this bill aims at providing a similar benefit to Hawaii companies securing federal renewable energy research and development awards. HTDC comments that while this benefit could enhance projects, the program goals should be clearly defined as providing an advantage in securing additional funding or commercialization of the technologies. Also, the bill has very narrow specifications. HTDC looks forward to working with legislators and industry in defining requirements that would be advantageous for a broader segment of the industry. HTDC also comments that to provide grants to companies, similar language to HRS 206M-15 would need to be adopted.

HTDC defers to the appropriate Departments regarding the budget implications of the program.
