## A BILL FOR AN ACT

RELATING TO VOTING.

**BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:**

1           SECTION 1. The legislature finds the voter turnout for  
2 young adults in Hawaii is one of the lowest in the country.  
3 Many young adults are unaware of the voter registration process  
4 and do not exercise their right to vote. Greater participation  
5 by young adults in the political process will help build a  
6 strong, civil-minded society.

7           The purpose of this Act is to:

- 8           (1) Require the department of education to provide seniors  
9           at every public school with voter registration  
10           information prior to graduation; and  
11           (2) Require the department of human services to provide  
12           young adults who are in the young adult voluntary  
13           foster care program with information on voter  
14           registration and authorize the department to assist  
15           young adults with registering to vote.

16           SECTION 2. Chapter 302A, Hawaii Revised Statutes, is  
17 amended by adding a new section to be appropriately designated  
18 and to read as follows:



1           "§302A- Voter registration information for seniors. The  
 2 department shall provide each senior at every public high school  
 3 with information on voter registration prior to graduation. The  
 4 department may determine the appropriate manner in which the  
 5 information shall be distributed."

6           SECTION 3. Chapter 346, Hawaii Revised Statutes, is  
 7 amended by adding a new section to part XIX to be appropriately  
 8 designated and to read as follows:

9           "§346- Voter registration information; registration  
 10 assistance. The department shall provide each young adult with  
 11 information on voter registration but may determine the  
 12 appropriate manner in which the information shall be  
 13 distributed. The department may also assist young adults with  
 14 voter registration."

15           SECTION 4. New statutory material is underscored.

16           SECTION 5. This Act shall take effect upon its approval.
