Your Committee on Conference on the disagreeing vote of the House of Representatives to the amendments proposed by the Senate in H.B. No. 894, H.D. 2, S.D. 1, entitled:

"A BILL FOR AN ACT RELATING TO THE ENHANCED 911 BOARD,"

having met, and after full and free discussion, has agreed to recommend and does recommend to the respective Houses the final passage of this bill in an amended form.

The purpose of this measure is to provide the Enhanced 911 Board (Board) the authority to employ staff.

Your Committee on Conference has amended this measure by:

- (1) Authorizing the Board to employ an executive director who would be exempt from civil service and collective bargaining laws;
- (2) Changing the effective date to July 1, 2015; and




- (3) Making technical, nonsubstantive amendments for clarity, consistency, and style.




