VIOLENCE BY A PARENT, TO ASSESS THE USE AND APPLICATION OF

The purpose of this measure is to assess the proper use and
application of Section 571-46(a)(9)-(14), Hawaii Revised Statutes,
by Family Court judges to address problems of family violence in
child custody disputes by requesting the Auditor to review and
report on all child custody proceedings where family violence has
been alleged to have been committed by a parent and that were
heard by the Family Courts from January 1, 2004, to December 31,
2009.

Safe Kids International and many individuals supported this
measure. The Judiciary provided comments on this measure.

As affirmed by the record of votes of the members of your
Committee on Human Services that is attached to this report, your
Committee concurs with the intent and purpose of H.C.R. No. 37 and
recommends that it be referred to the Committee on Judiciary.


