for one ambulance unit to service the area of Kakaako.


Your Committee received testimony in support of this measure

received comments on this measure from the Department of Health.

Your Committee finds that the population of the area of
Kakaako in the City and County of Honolulu has recently undergone
a dramatic increase in population. There has been the development
of numerous residential condominiums and an increase in businesses
serving the residents. Correspondingly, there has been a steady
and marked increase of calls for emergency medical services in the
Kakaako area.

As affirmed by the record of votes of the members of your
Committee on Health that is attached to this report, your
Committee is in accord with the intent and purpose of S.B.
No. 1006 and recommends that it pass Second Reading and be
referred to the Committee on Ways and Means.
