A BILL FOR AN ACT

RELATING TO EDUCATION.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The Hawaii Keiki: Healthy and Ready to Learn
2 program is designed to improve the access and quality of health
3 services available to schoolchildren by coordinating and
4 expanding the existing efforts of community partners and
5 resources. This program sits at the intersection of education
6 and health to support the department of education in achieving
7 student, school, and system success.

8 The Hawaii Keiki: Healthy and Ready to Learn program builds
9 and enhances school-based health services that:

- 10 (1) Screen for treatable health conditions;
- 11 (2) Provide referral to primary health care and patient-
12 centered medical home services;
- 13 (3) Prevent and control communicable disease and other
14 health problems; and
- 15 (4) Provide emergency care for illness or injury.

16 Working with each complex area superintendent, the Hawaii Keiki:
17 Healthy and Ready to Learn program will create services that
18 reflect the specific needs of the individual complex area in



1 light of student demographics, staffing, available support
2 services, and access to health care within the community.

3 The purpose of this Act is to support the Hawaii Keiki:
4 Healthy and Ready to Learn program by appropriating funds for
5 the program.

6 SECTION 2. There is appropriated out of the general
7 revenues of the State of Hawaii the sum of \$1,000,000 or so much
8 thereof as may be necessary for fiscal year 2015-2016 and the
9 same sum or so much thereof as may be necessary for fiscal year
10 2016-2017 for expenses of the Hawaii Keiki: Healthy and Ready to
11 Learn program; provided that the \$1,000,000 for fiscal year
12 2016-2017 shall be expended for the Hawaii Keiki program only
13 if, during the fiscal year, the department of education receives
14 and expends non-state funds of at least \$500,000 for the
15 program.

16 The sums appropriated shall be expended by the department
17 of education for the purposes of this Act.

18 SECTION 3. This Act shall take effect on July 1, 2015.
