# A BILL FOR AN ACT

RELATING TO THE YOUTH CONSERVATION CORPS.

**BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:**

1           SECTION 1. Currently, part IV of chapter 193, Hawaii  
2 Revised Statutes, titled Youth Conservation Corps, principally  
3 applies to the State's youth conservation corps program. This  
4 Act distinguishes this state program from other federal and  
5 nationally affiliated Youth Conservation Corps programs by  
6 changing statutory references, including the title of part IV of  
7 chapter 193, Hawaii Revised Statutes, from Youth Conservation  
8 Corps to Hawaii Youth Conservation Corps to avoid confusion.

9           SECTION 2. Chapter 193, part IV, Hawaii Revised Statutes,  
10 is amended by amending its title to read as follows:

11                   "~~[-]~~PART IV. ~~[+]~~ HAWAII YOUTH CONSERVATION CORPS"

12           SECTION 3. Section 247-7, Hawaii Revised Statutes, is  
13 amended to read as follows:

14           "§247-7 **Disposition of taxes.** All taxes collected under  
15 this chapter shall be paid into the state treasury to the credit  
16 of the general fund of the State, to be used and expended for  
17 the purposes for which the general fund was created and exists  
18 by law; provided that of the taxes collected each fiscal year:



- 1           (1) Ten per cent shall be paid into the land conservation  
2           fund established pursuant to section 173A-5;
- 3           (2) Twenty-five per cent from July 1, 2009, until June 30,  
4           2012; thirty per cent from July 1, 2012, until June  
5           30, 2014; and fifty per cent in each fiscal year  
6           thereafter shall be paid into the rental housing trust  
7           fund established by section 201H-202; and
- 8           (3) Twenty per cent from July 1, 2009, until June 30,  
9           2012, and twenty-five per cent in each fiscal year  
10          thereafter shall be paid into the natural area reserve  
11          fund established by section 195-9; provided that the  
12          funds paid into the natural area reserve fund shall be  
13          annually disbursed by the department of land and  
14          natural resources in the following priority:
  - 15           (A) To natural area partnership and forest  
16           stewardship programs after joint consultation  
17           with the forest stewardship committee and the  
18           natural area reserves system commission;
  - 19           (B) Projects undertaken in accordance with watershed  
20           management plans pursuant to section 171-58 or  
21           watershed management plans negotiated with



1 private landowners, and management of the natural  
2 area reserves system pursuant to section 195-3;  
3 and

4 (C) The Hawaii youth conservation corps established  
5 under chapter 193."

6 SECTION 4. Statutory material to be repealed is bracketed  
7 and stricken. New statutory material is underscored.

8 SECTION 5. This Act shall take effect upon its approval.
