
A BILL FOR AN ACT

RELATING TO HEALTH.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that sexuality health
2 education promotes healthy attitudes on adolescent growth and
3 development, body image, gender and sexuality, dating,
4 relationships, and family. The legislature also finds that
5 sexuality health education should positively affect adolescent
6 behavior and provide teens with the information, skills, and
7 support they need to develop positive values, make healthy
8 decisions, and respect the important role that sexuality plays
9 throughout a person's life. Within the past few years, several
10 states, including Hawaii, have enacted laws that require school
11 districts that teach sexuality health education to include age
12 appropriate, medically accurate health education. The
13 legislature finds that the effectiveness of sexuality health
14 education in Hawaii's schools could be bolstered by providing
15 clearer guidance on a comprehensive approach to sexuality health
16 education, greater flexibility in the implementation of the
17 curricula, and greater public access to the curricula.

18 The purpose of this Act is to:



1 (1) Specify additional elements in Hawaii's sexuality
2 health education law, including additional criteria
3 regarding implementation of sexuality health education
4 instruction; and

5 (2) Require the department of education to provide
6 information on the curricula to the public.

7 SECTION 2. Section 321-11.1, Hawaii Revised Statutes, is
8 amended to read as follows:

9 "[+]§321-11.1[+] **Medically accurate sexuality health**
10 **education.** (a) Sexuality health education programs funded by
11 the State shall provide medically accurate and factual
12 information that [~~is~~]:

13 (1) Is age appropriate [~~and includes~~];

14 (2) Includes education on abstinence, monogamy,
15 contraception, and methods of disease prevention to
16 prevent unintended pregnancy and sexually transmitted
17 disease, including human immunodeficiency virus[-];

18 (3) Helps students develop relationships and communication
19 skills to form healthy relationships that are based on
20 mutual respect and affection and free from violence,
21 coercion, and intimidation;



- 1 (4) Helps students develop skills in critical thinking,
2 problem solving, decision making, and stress
3 management to make healthy decisions about sexuality
4 and relationships; and
- 5 (5) Encourages students to communicate with their parents,
6 guardians, and other trusted adults about sexuality
7 and intimate relations.
- 8 (b) Beginning with the 2016-2017 school year, each public
9 elementary, middle, intermediate, high, and alternative school
10 operated by the department of education shall provide sexuality
11 health education described under subsection (a); provided that:
- 12 (1) Parents or guardians of students in kindergarten
13 through fifth grade may opt-in to permit their child
14 to participate in sexuality health education programs;
15 and
- 16 (2) Parents or guardians of students in grades six through
17 twelve may opt-out to deny permission for their child
18 to participate in sexuality health education programs.
- 19 (c) At their own discretion, teachers may answer in good
20 faith any question initiated by a student or students that is



1 reasonably related to and consistent with the material of a
2 course provided pursuant to subsection (a).

3 (d) The department of education may eliminate or modify
4 components of instruction under subsection (a)(2) in elementary
5 school for reasons of age appropriateness.

6 (e) Sexuality health education under subsection (a) shall
7 not discriminate on the basis of sex, race, ethnicity, national
8 origin, disability, religion, sexual orientation, or gender
9 identity.

10 (f) The department of education shall develop, maintain,
11 and make available to the public a current list of sexuality
12 health education curricula that are consistent with the
13 requirements under subsection (a).

14 ~~[-(b)-]~~ (g) For the purposes of this section:

15 "Age appropriate" means suitable to a particular age or age
16 group based on developing cognitive, emotional, and behavioral
17 capacity typical for that age or age group.

18 "Factual information" means medical, psychiatric,
19 psychological, empirical, or statistical information that is
20 verified or supported by research conducted by recognized



1 medical, psychiatric, psychological, and public health
2 professionals or organizations.

3 "Medically accurate" means verified or supported by
4 research conducted in compliance with accepted scientific
5 methods and recognized as accurate and objective by professional
6 organizations and agencies with expertise in the relevant field,
7 such as the federal Centers for Disease Control and Prevention,
8 the American Public Health Association, the American Academy of
9 Pediatrics, and the American College of Obstetricians and
10 Gynecologists.

11 "Sexuality health education" means education in any medium
12 regarding human development and sexuality, including education
13 on pregnancy, family planning, and sexually transmitted
14 diseases."

15 SECTION 3. Statutory material to be repealed is bracketed
16 and stricken. New statutory material is underscored.

17 SECTION 4. This Act shall take effect on July 1, 2050.
