
HOUSE RESOLUTION

REQUESTING THE AUDITOR TO CONDUCT A FINANCIAL AND MANAGEMENT
AUDIT OF THE PLANT QUARANTINE BRANCH OF THE DEPARTMENT OF
AGRICULTURE AND EVALUATE A PROPOSAL TO MOVE THE PLANT
QUARANTINE BRANCH TO THE DEPARTMENT OF TRANSPORTATION.

1 WHEREAS, Hawaii's tourism industry heavily relies on
2 Hawaii's unique environment; and
3

4 WHEREAS, there are more endangered species in the State of
5 Hawaii than in any other state in the United States, and of all
6 the plants and birds known to be extinct in the United States,
7 two-thirds are from Hawaii; and
8

9 WHEREAS, introduced, non-native species have and will
10 continue to have devastating impacts on Hawaii's agriculture,
11 natural environment, economy, public health, and quality-of-
12 life; and
13

14 WHEREAS, once established, invasive species cause millions
15 of dollars in damage to agriculture and the environment, serious
16 public concerns, and cannot readily be eradicated; and
17

18 WHEREAS, without vigilant inspection, the public health,
19 safety, and welfare is in danger from introduction and
20 establishment of these insects, diseases, viruses, and
21 prohibited and restricted plants and animals; and
22

23 WHEREAS, the only two pathways for introduced, non-native
24 species to arrive in Hawaii are through air and maritime
25 transportation; and
26

27 WHEREAS, air transportation has been proven to be the
28 highest-risk pathway, transporting introduced species that are
29 much more likely to become established, as well as various
30 illegal plants and animals; and

1 WHEREAS, the inspection at the marine ports is considered
2 the most effective quarantine measure to reduce entry of
3 unwanted animals and plants into Hawaii; and
4

5 WHEREAS, the community and the Legislature feel that the
6 importance of prohibiting non-native species is a priority and
7 is required at all ports; and
8

9 WHEREAS, members of the agricultural sector, environmental
10 sector, and the community have expressed concern over the
11 Department of Agriculture's lack of transparency and progress on
12 the implementation of the biosecurity program established
13 pursuant to section 150A-51, Hawaii Revised Statutes; and
14

15 WHEREAS, specifically, there are increased concerns about
16 the Department of Agriculture's inability to hire inspectors in
17 a timely manner; now, therefore,
18

19 BE IT RESOLVED by the House of Representatives of the
20 Twenty-eighth Legislature of the State of Hawaii, Regular
21 Session of 2015, that the Auditor is requested to conduct a
22 financial and management audit of the Plant Quarantine Branch of
23 the Department of Agriculture; and
24

25 BE IT FURTHER RESOLVED that the Legislature requests that
26 the audit include:
27

- 28 (1) A discussion on the current state of the Plant
29 Quarantine Branch of the Department of Agriculture;
30
- 31 (2) Recommendations on the necessary resources needed for
32 the Plant Quarantine Branch to fully and properly
33 carry out its purpose and responsibilities pursuant to
34 chapter 150A, Hawaii Revised Statutes; and
35
- 36 (3) An evaluation of a proposal to move either part or all
37 of the functions of the Plant Quarantine Branch to the
38 Department of Transportation; and

40 BE IT FURTHER RESOLVED that the Auditor is requested to
41 submit any findings, recommendations, and any proposed
42 legislation to the Governor and the Legislature no later than



1 twenty days prior to the convening of the Regular Session of
2 2016; and




