A BILL FOR AN ACT

RELATING TO MANUFACTURING.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. Chapter 206M, Hawaii Revised Statutes, is
2 amended by adding a new section to be appropriately designated
3 and to read as follows:

4 "§206M- Manufacturing development program; established.

5 (a) There is established the manufacturing development program,
6 through which the development corporation may provide grants to
7 any business in Hawaii that is a manufacturer in the State and
8 requires assistance for any of the following items:

9 (1) Purchasing of manufacturing equipment;

10 (2) Training of employees on the use of manufacturing
11 equipment; or

12 (3) Improving existing energy efficiency manufacturing
13 equipment or the purchase of improved energy
14 efficiency equipment in the manufacturing process;

15 provided that no grant shall exceed 20 per cent of the cost of
16 any of the above items, and no company shall receive a grant
17 exceeding \$20,000 in any given year.



1 (b) All moneys necessary to carry out the purposes of this
2 section shall be appropriated by the legislature through
3 appropriations out of the state general fund.

4 (c) In reviewing grant applications pursuant to this
5 section, the development corporation shall analyze each
6 application to determine whether the item to be undertaken will
7 be economically viable and beneficial to the State.

8 (d) The development corporation shall submit a report to
9 the legislature no later than twenty days prior to the convening
10 of the regular session held in every even-numbered year. The
11 report shall include the following items:

- 12 (1) The total number of grants provided;
13 (2) The sectors provided with grants;
14 (3) The total projected economic and employment growth
15 facilitated by the grants provided; and
16 (4) The actual economic and employment growth that
17 occurred as a result of the grants provided."

18 SECTION 2. There is appropriated out of the general
19 revenues of the State of Hawaii the sum of \$1,000,000 or so much
20 thereof as may be necessary for fiscal year 2015-2016 and the
21 same sum or so much thereof as may be necessary for fiscal year

1 2016-2017 to facilitate the provision of grants by the high
 2 technology development corporation to manufacturing businesses
 3 in Hawaii for certain purchases and employee training purposes.


4 The sums appropriated shall be expended by the high
 5 technology development corporation for the purposes of this Act.

6 SECTION 3. The high technology development corporation
 7 shall include in its base budget request for the subsequent
 8 fiscal period the amounts necessary to effectuate this Act.

9 SECTION 4. This Act shall take effect on July 1, 2015.
